My research focuses on the development of children's self-regulation and externalizing behavior, their associations with parents' mental health, caregiving, and their contributions to psychopathology. I follow a biopsychosocial approach to studying development, psychopathology, and family processes with survey, behavioral, observational, neuropsychological, and biological methods. My lab is collecting data on children's and parents' self-regulation, executive functions, psychophysiological markers of stress reactivity and regulation, screen media use, and parent-child interactions.
