## III. The Housing Market

An understanding of the housing market, that is, of the process and efficiency with which people and dwellings are matched to each other, is central to the formulation of housing policy. For example, one of the most crucial of housing problems, housing shortages, occurs when the number of people seeking homes exceeds the number of available housing units. Why and how does this happen? What strategies may be applied to deal with it?

Economics have developed some of the most useful and powerful conceptual tools to help us answer these questions. They offer the notion of a <u>market</u> to describe the relationships between the supply, demand, and price of housing. This section examines the competitive model of the housing market, exploring its strengths and limitations as a tool for describing and analyzing the actual operation of contemporary housing markets.
